Scope of This Privacy Notice

This Privacy Notice applies to data obtained by NAGASE.

This Privacy Notice does not apply to data collected by any third party, including through any application or content that may link to or be accessible from or on our Website.

This Privacy Notice is subject to any additional terms of disclaimers or other contractual terms you have entered into with NAGASE such as client privacy statements or notices, and any applicable laws, regulations, and guidelines on the protection of Personal Data. Please be aware that for certain services, NAGASE may provide you with privacy statements in addition to, or in place of, this Privacy Notice, as appropriate.

Definitions

In this Privacy Notice, the following terms have the following meanings:

"Personal Data" means any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier, or to reference to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

"Process" or "Processing" means any operation or set of operations which is performed on Personal Data or on sets of Personal Data, whether or not by automated means, such as collection, recording, organization, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure, or destruction.

Data We Collect About You

We may Process different kinds of Personal Data about you which we have grouped together as follows: · Identity Data includes name, country, company, position, employer number, user account data, date of birth and gender.

- · Contact Data includes email address, telephone numbers, office location address, billing address, delivery address.
- Financial Data includes bank account and payment card details.
- · Technical Data includes internet protocol (IP) address, date and time of your access, time zone setting and location, browser type and version, your device identifies, your internet or wireless service provider and other technology on the devices you use to access this Website. We do not collect following data from you:
